Community Investments

- A second in-person FY24 Reporting Training for new CMHF partners and those with provisional contracts was conducted at the Carpenter Library August 31
- A 12-month No-Cost Extension for the current SAMHSA SOC grant due to end 9/29/23 is pending as is a new 4-year SAMHSA SOC Cooperative Agreement for 9/2023 – 9/2026.
 The focus of the SOC grant is children and youth with a serious emotional disturbance or at risk for that identify as LGBTQIA+ and/or are experiencing or at-risk for homelessness.
- Program Staff are meeting with four of the five hybrid CCSF/CMHF Funded Partners to adjust their FY24 Contracted Outcomes to align with available CCSF and CMHF funding, based on FY23 participant data.

Other

- A Youth Mental Health First Aid Initiative Planning Meeting was held August 25 in
 partnership with the St. Louis County Children's Service Fund, MHB Funded Partners, and
 CSF Funded partners that provide YMHFA trainings at Delmar DevINe. The purpose of the
 meeting was to learn about Funded Partners YMHFA training efforts and to coordinate future
 trainings in an effort to increase the number of school staff and community members able to
 participate in trainings during FY24.
