- **1a.** <u>Call to Order</u> The regular meeting of the City of St. Louis Mental Health Board of Trustees (MHB) was called to order at 5:45 p.m. by Board Chair Donna Schmitt.
- 1b. <u>Community Comments</u> Alderwoman Shameen Clark-Hubbard spoke in support of the Sidewalk Talk event held May 6 on Delmar in the West End Neighborhood in recognition of Mental Health Awareness Month. Gerry Connolly questioned the Board's process of conducting a vote within the closed session. Chair Schmitt explained that the Board can conduct the vote in the closed session per statute.
- Approval of the April 2025 Board Minutes The motion to approve the April 17, 2025, meeting minutes was made by Rob Poirier, seconded by Carolyn Jackson, and passed unanimously.
- **3.** <u>FY25 Q3 Financial Report</u> Executive Director Cassandra Kaufman presented the FY25 Q3 financial report.
- 4. Resolution to Approve FY26 Continuation Grants from the Community Mental Health Fund Vice Chair and Program Committee Chair Rob Poirier presented the resolution and made the motion to approve FY26 continuation funding for year three of the Community
