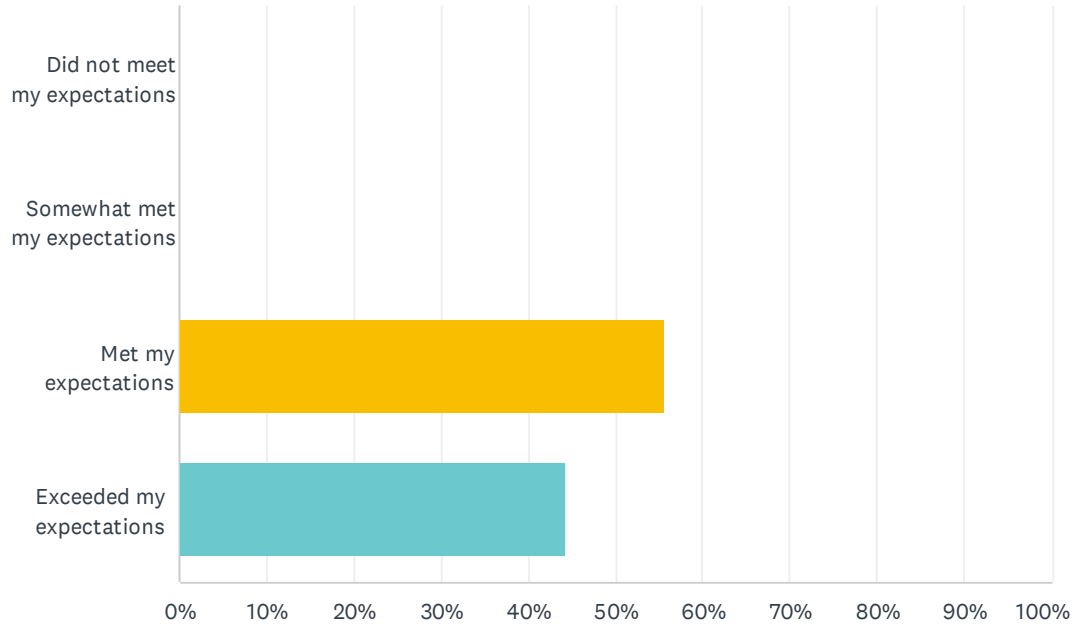


Q1 Overall organization and flow of the Board retreat...

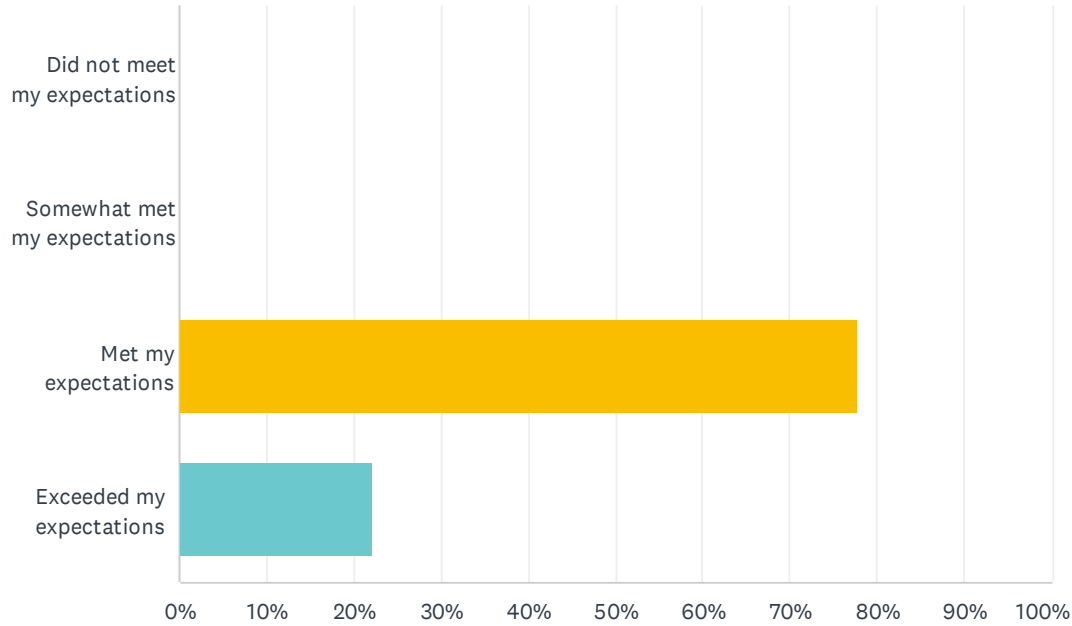

Q2 Overall participation and interaction among Trustees...

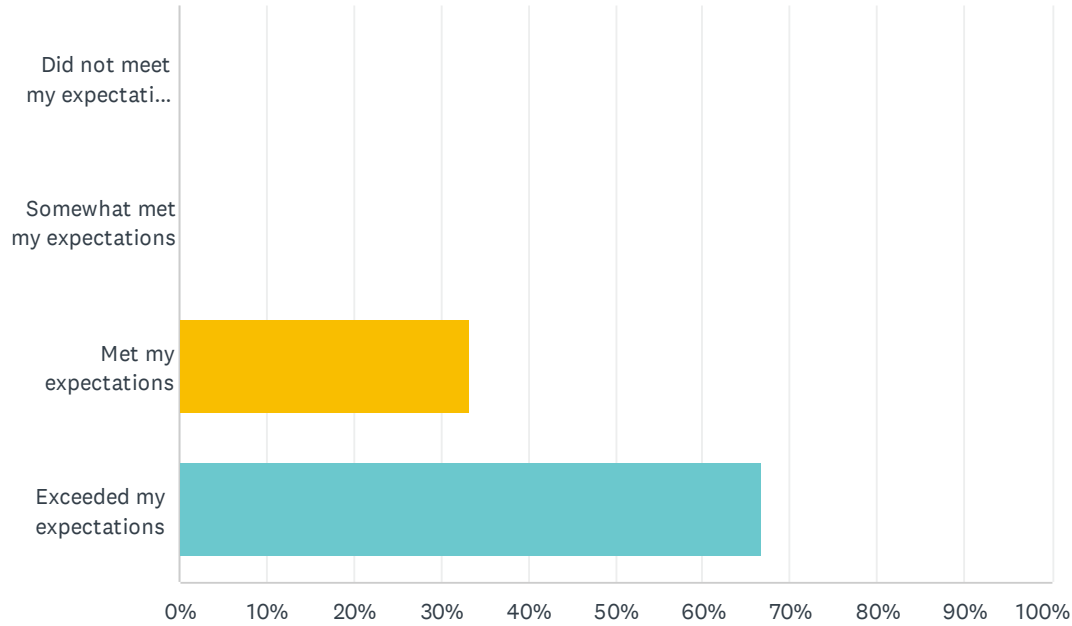

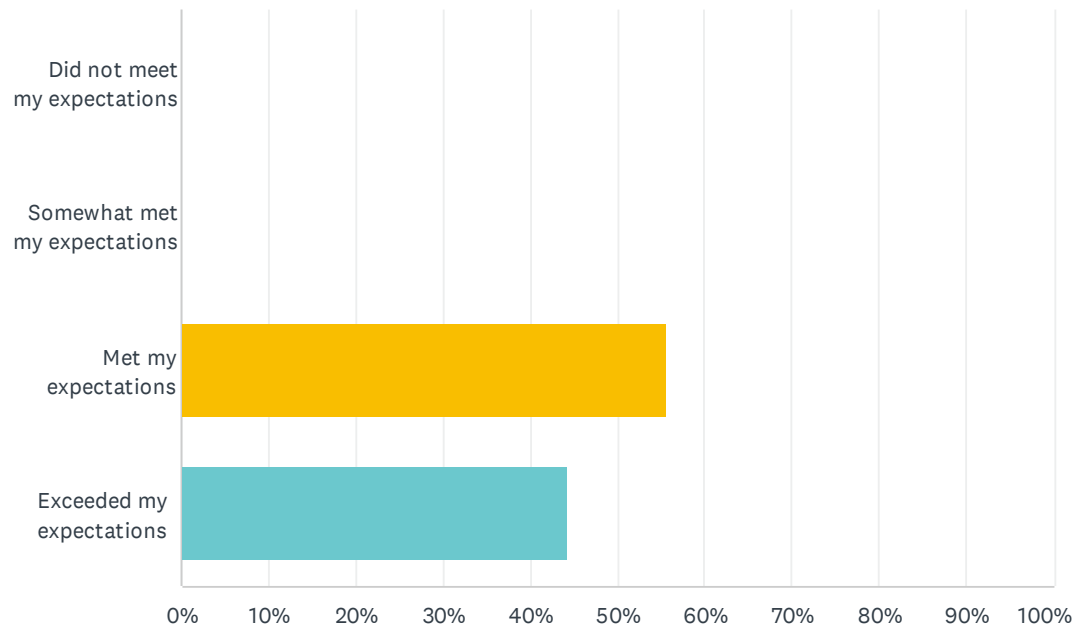

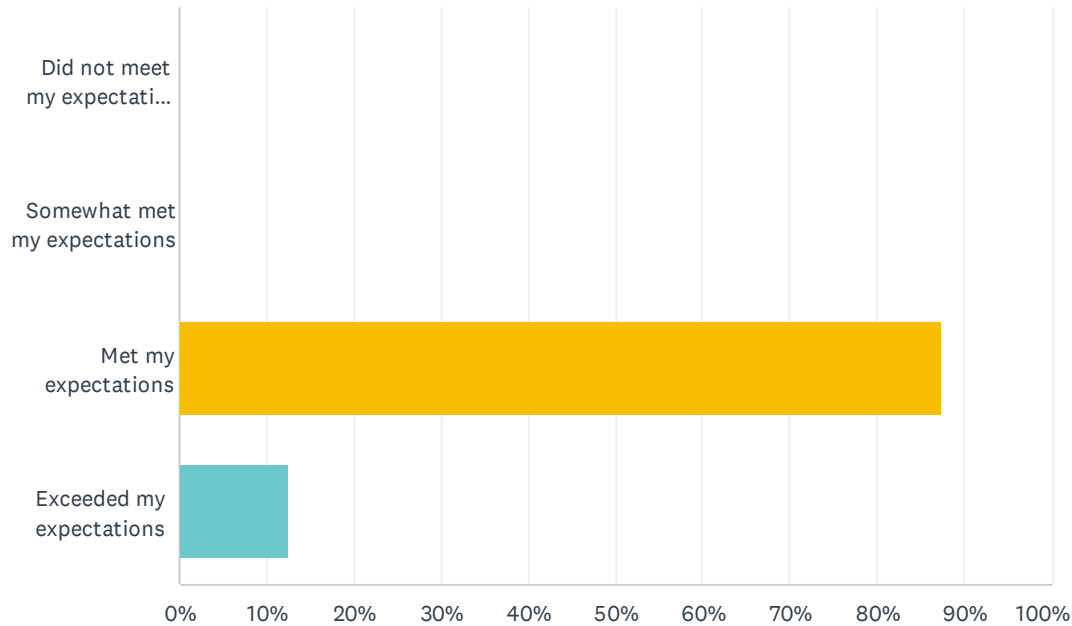
